COURSE OF FIRE
STANDARD OPERATING PROCEDURES

[GENERAL OPERATIONS]

I.) RANGE SET UP

- a. See attached (SITE LAYOUT) documents for detailed range set up overview and Personnel Positions
- b. For set up of "Rifle/Tactical Carbine COF" the ONLY modification to the site set up is in moving the fire line to 50 Meters from furthest target, and setting target stands to 15M, 30M, and 50M

II.) WEAPON INFORMATION / TARGET TYPES / NECESSARY EQUIPMENT

- a. The Pistol Course of Fire is to be restricted to weapons with no greater than 6 inch barrel/bore lengths
- b. Shoulder fired weapons are not considered pistols, and must only be used for scoring on the tactical carbine or rifle COF
 - i. SBRs, Sub Machine Guns, Pistol Caliber Carbines, and Pistol braces/ weapons with pistol braces are not eligible for scoring under the PISTOL COF.
 - ii. Expectations can be made by Course Master (CM) for shooters with disabilities, annotated on score card.
- c. Accuracy Courses of Fire requires two magazines minimum to complete, a magazine change is apart of the COF for scoring
 - i. Shooters can use revolvers or weapons with Magazines under 9 round capacity, but will not be provided additional time or resources to complete a third magazine change.
- d. The Rifle/Tactical Carbine/PCC COF does not have limitations on barrel length, caliber, Optics, Grips, Braces, or attachments. Limitations are subject only to the hosting range SOP for Caliber, Rate of Fire, Ammo Type etc.
- e. **SHOOTER EQUIPMENT**
 - i. The shooter on the firing line must have the following equipment:
 1. Eye Protection
 2. Ear Protection
 3. 2 Magazines for their weapon (minimum)
 4. A place to hold the second magazine on their body (pocket, magazine pouch, etc.)
- f. **RSO EQUIPMENT [PERSONNEL DUTIES SOPS]**
- g. **RANGE EQUIPMENT [SEE LAYOUT FOR DETAILS]**
 - i. Minimum 5 Tables
 1. Check in Table

2. Firing Line Table
3. Ammo Table
4. Cased Weapon Table
5. Target Table

- ii. Ammo Stands do not have a height requirement, but RSO 1-0 maintains primary responsibility to ensure bullet impacts are in intended area, set target heights accordingly to achieve this.
- iii. Flags, Every RSO must have a weapon flag on them and three must be located on the Weapon Table
- iv. SEE PERSONNEL DUTIES SOP for equipment assignments
- v. SEE COF PAPERWORK DOCUMENT FOR SCORECARDS, MATCH LOG, AND COURSE OF FIRE INSTRUCTION.
